The paper in Chinese is limited to 10 pages and should include Chinese and English titles, abstracts, and author's information (academic experience/affiliation, full address, telephone, and e-mail) and the appropriate field (i.e., Marketing Management, Business Administration, Information Management, Finance, Industrial Engineering and Management, etc.). All submitted papers will be reviewed by program committee members and selected based on their originality, significance, relevance, and clarity of presentation.
